



Terms and Conditions

Free 100GB BoxBiz Lite Cloud Storage Account with HP Win 8 Professional PC (the "Promotion")

These Terms and Conditions govern the Promotion. The Promotion is promoted by HP Limited, Amen Corner, Cain Road, Bracknell, RG12 1HN ("HP").

Conditions of Entry

1. By entering the Promotion, you agree to the provisions of these Terms and Conditions and to comply fully with them.
2. The Promotion is open to UK residents [aged 18 or over] excluding HP employees, subsidiaries, families, agents, affiliates, or anyone involved in running the Promotion and anyone closely related to them.
3. To enter the Promotion you must register for a 100GB Box Biz Lite Cloud Storage Account ("Account") via the preloaded BOX icon on a qualifying Windows 8 Professional HP PC ("Qualifying Product") purchased between 1 November 2012 and midnight on 31 August 2013 ("Promotional Period").
4. Registration must be made by you. Resellers may not register on behalf of their customers. You will be required to accept the BOX terms and conditions upon registration. Once registration is completed, you will see an onscreen email verification message and receive an email from BOX to verify your registration. Upon receipt of this email, you should follow instructions to verify the Account and upon completion of verification, you will be taken to the BOX login screen. Please note usage of the Account is governed by the BOX terms and conditions and are in no way linked to HP.
5. You must register for an Account by midnight on 31st August 2013.
6. The Promotion is only open to you if you are a new Box Business customer.
7. Only one Account per company is permitted, with a maximum of 20 employees able to register for the Account. This will be monitored at registration using the email URL as a reference. Where multiple individuals have purchased a Qualifying Product within one company, each individual will be able to register for an Account but the 100GB storage space will be shared e.g. if 2 employees of the same company register for an Account, each employee will receive a 50GB storage space or if 20 employees from the same company registered for an Account, each employee will receive a 5GB storage space.

13. HP is not responsible or liable for any technical, hardware, software, server, website, or other failures or damage of any kind to the extent that this prevents you from participating in the Promotion.

To the maximum extent permitted by law, HP excludes its liability for any loss, damage, injury, cost or expense suffered by you, whether directly or indirectly and howsoever caused, in connection with the Promotion and use of the Account. Nothing in these Terms and Conditions shall exclude HP's liability for death or personal injury arising from HP's own negligence or any other liability that cannot as a matter of law, be excluded.
